REVIEW OF CONTRACT DOCUMENTS:

- a. THE CONTRACTOR SHALL BE RESPONSIBLE FOR THOROUGHLY REVIEWING THESE CONSTRUCTION DOCUMENTS AND ACQUAINTING HIMSELF WITH THE REQUIREMENTS HEREIN. PRIOR TO THE SUBMISSION OF THE PRICE AND SCHEDULE ACCEPTANCE BY THE OWNER, CONTRACTOR SHALL VISIT THE SITE AND FAMILIARIZE HIMSELF WITH CONDITIONS AFFECTING MECHANICAL, ELECTRICAL, COMMUNICATIONS, PLUMBING, AND ANY OTHER INSTALLATION, AS WELL AS GENERAL LOCAL CONDITIONS, PARTICULARLY THOSE BEARING UPON TRANSPORTATION, CODES AND ORDINANCES, AVAILABILITY OF LABOR, AND OTHER SUCH MATTERS AND SHALL MAKE PROVISIONS AS TO THE COST THEREOF. ANY FAILURE TO DO SO WILL NOT RELIEVE CONTRACTOR FROM THE RESPONSIBILITY PERFORMING THE WORK.
- b. SHOULD CONTRACTOR, IN PREPARING THE PRICE AND SCHED-ULE, FIND ANY DISCREPANCY, INCONSISTENCY, CONFLICT OR OMISSION IN, OR BE IN DOUBT AS TO THE EXACT MEANING OF THE CONSTRUCTION DOCUMENTS HE SHALL PROMPTLY AND, BEFORE PROCEEDING FURTHER, NOTIFY OWNER'S REPRESENTATIVE IN WRITING. OWNER'S REPRESENTATIVE SHALL NOTIFY THE ARCHITECT WHO WILL RESOLVE SUCH DISCREPANCY AND FURNISH CONTRACTOR WITH WRITTEN INSTRUCTIONS WITH RESPECT THERETO. IF CONTRACTOR FAILS TO MAKE SUCH WRITTEN NOTIFICATION, CONTRACTOR SHALL BE RESPONSIBLE FOR FAILURE TO CARRY OUT WORK IN A SATISFACTORY MANNER. IF SUCH A CONFLICT OCCURS IN THE CONSTRUCTION DOCUMENTS, THE CONTRACTOR SHALL BE DEEMED TO HAVE ESTIMATED ON THE MORE EXPENSIVE CONSTRUCTION MATERIALS AND METHODS.
- c. CONTRACTOR SHALL DILIGENTLY PURSUE THE WORK TO COMPLETION AND IN ACCORDANCE WITH THE CONTRACT DOCUMENTS.
- FIELD MEASUREMENTS/CONDITIONS:
- a. CONTRACTOR SHALL VERIFY CONDITIONS, MEASUREMENTS AND EQUIPMENT AT THE SITE AND WILL BE HELD RESPONSIBLE FOR THE CORRECTNESS OF HIS WORK AND WILL BE REQUIRED TO REPLACE INCORRECT WORK WITH NEW. CONTRACTOR SHALL NOTIFY THE OWNER'S REPRESENTATIVE AT ONCE AND IN WRITING IF ANY DISCREPANCIES OR OMISSIONS WHICH WOULD INTERFERE WITH SATISFACTORY COMPLETION OF THE WORK ARE DISCOVERED OR IF MEASUREMENTS CANNOT BE SECURED FOR ANY PART OF THE WORK. CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING CLARIFICATION FROM THE OWNER'S REPRESENTATIVE PRIOR TO CONTINUING WORK IN THE AREA IN QUESTION.
- b. CONTRACTOR SHALL DETERMINE MAXIMUM SIZE AND WEIGHT OF EQUIPMENT, FIXTURES OR UNITS THAT CAN BE TAKEN INTO THE BUILDING AND/OR PREMISES THROUGH OPENINGS AVAILABLE.
- C. CONTRACTOR SHALL COORDINATE HIS WORK, HIS SUBCONTRACTOR'S WORK, AND WORK OF THE OWNER'S SEPARATE CONTRACTORS WHOSE WORK IS INCLUDED IN THE CONTRACT DOCUMENTS SO AS TO AVOID CONFLICTS BETWEEN SUBCONTRACTORS AND WITH OTHER CONTRACTORS. ANY CHANGES IN WORK RESULTING FROM FAILURE TO SO COORDINATE, AND ANY LOSS, EXPENSE OR DAMAGE RESULTING FROM INJURY TO THE WORK AS ONE SUBCONTRACTOR OR TRADE CAUSED BY OPERATIONS OF ANOTHER, SHALL BE CONTRACTOR'S RESPONSIBILITY.

. SAFETY

CONTRACTOR SHALL EXERCISE PRECAUTION AT ALL TIMES FOR THE PROTECTION OF PERSONS (INCLUDING EMPLOYEES) AND PROPERTY AND OBSERVE THE PROVISIONS OF APPLICABLE LAWS, BUILDING AND CONSTRUCTION CODES AND OSHA. IN NO CASE SHALL THE OWNER, OWNER'S REPRESENTATIVE OR ARCHITECT BE RESPONSIBLE FOR CONSTRUCTION MEANS, METHODS, TECHNIQUES, SEQUENCES OR PROCEDURES, OR FOR SAFETY PRECAUTIONS AND PROGRAMS IN CONNECTION WITH THE WORK, NOR SHALL THE OWNER, OWNER'S REPRESENTATIVE OR ARCHITECT BE RESPONSIBLE FOR CONTRACTOR'S FAILURE TO EMPLOY PROPER SAFETY PROCEDURES.

c. HAZARDOUS MATERIALS

UNDER NO CIRCUMSTANCES SHALL THE HANDLING, REMOVAL OR DISPOSAL OF HAZARDOUS MATERIALS (INCLUDING BUT NOT BY WAY OF LIMITATION ASBESTOS) BE UNDERTAKEN AS PART OF THE WORK OF THIS CONTRACT. NOTIFY THE OWNER'S REPRESENTATIVE IMMEDIATELY OF ANY HAZARDOUS MATERIALS ENCOUNTERED AND ONLY PROCEED WHEN AND AS DIRECTED BY THE OWNER'S REPRESENTATIVE.

PROTECTION OF EXISTING CONDITIONS

- a. CONTRACTOR SHALL PROTECT ALL EXISTING STRUCTURES, UTILITIES, SIGNS AND INSTALLATIONS OF ANY KIND AGAINST DAMAGE OR INTERRUPTION OF SERVICE. HE SHALL AT ALL TIMES PROTECT AND PRESERVE ALL MATERIALS, SUPPLIES AND EQUIPMENT OF EVERY DESCRIPTION INCLUDING ALL WORK PERFORMED AND PROPERTY WHICH MAY BE OWNER-FURNISHED OR OWNED. INTERRUPTIONS OF SERVICES, RESULTING FROM FAILURE TO ADEQUATELY PROTECT UTILITY INSTALLATION SHALL BE PROMPTLY REPAIRED AND RESTORED AT CONTRACTOR'S EXPENSE. THE CONTRACTOR SHALL NOTIFY THE OWNER'S REPRESENTATIVE OF ANY IMPENDING INTERRUPTION OF SERVICE.
- b. CONTRACTOR SHALL HOLD DUST TO A MINIMUM DURING DEMOLITION AND CONSTRUCTION. CONTRACTOR SHALL PROVIDE PLASTIC BARRIER WALLS TO CONTROL ENVIRONMENT. CONTRACTOR SHALL BE FINANCIALLY RESPONSIBLE FOR ANY DAMAGES CAUSED TO EXISTING OPERATIONS FROM NEGLIGENCE ON GENERAL CONTRACTOR'S PART REGARDING PROTECTION.
- c. THE CONTRACTOR IS RESPONSIBLE FOR ANY DAMAGE TO EXISTING STRUCTURES, WALLS, DOORS, FRAMES, FLOOR MATERIALS, CEILINGS, ETC. AND TO TENANT'S FURNITURE, FIXTURES, AND EQUIPMENT WHICH OCCURS DURING THE PROSECUTION OF THE WORK. ALL COSTS FOR REPAIR OF THIS DAMAGE SHALL BE THE RESPONSIBILITY OF THE CONTRACTOR.
- d. THE CONTRACTOR IS RESPONSIBLE FOR NOTIFYING THE OWNER'S REPRESENTATIVE OF ANY DAMAGE DONE BY OTHERS OR OF ANY EXISTING DAMAGE FOUND PRIOR TO START-UP OF THE WORK.
- WORKMANSHIP AND MATERIALS
- a. ALL WORKMANSHIP SHALL BE OF THE HIGHEST QUALITY WHICH IS CURRENTLY PREVAILING IN THE TRADE.
- b. UNLESS OTHERWISE SPECIFIED, ALL MATERIALS, SUPPLIES, PARTS, EQUIPMENT AND ARTICLES INCORPORATED IN THE WORK SHALL BE NEW AND OF RECENT MANUFACTURE, FREE FROM DEFECTS AND IMPERFECTIONS. WHENEVER PRACTICABLE, THE STANDARD PRODUCT OF A RECOGNIZED, REPUTABLE MANUFACTURER SHALL BE USED. REFERENCE TO ANY ARTICLE, DEVICE, PRODUCT, MATERIAL, FIXTURE, FORM OR TYPE OF CONSTRUCTION BY NAME, MAKE OR CATALOG NUMBER ESTABLISHES A STANDARD OF QUALITY AND SHALL NOT BE CONSTRUED AS A LIMITATION UPON COMPLETION.
- C. CONTRACTOR MAY ONLY SUBSTITUTE MATERIALS AND ARTICLES OF QUALITY AND MERIT ACCEPTED BY THE ARCHITECT AS EQUAL TO THOSE SPECIFIED AND WITH THE OWNER'S PRIOR WRITTEN APPROVAL. REQUESTS FOR SUBSTITUTIONS SHALL BE SUBMITTED IN WRITING TO THE OWNER'S REPRESENTATIVE AND SHALL BE ACCOMPANIED BY TECHNICAL INFORMATION AND DATA DESCRIBING QUALITY, PERFORMANCE, ETC. TO PROVIDE A PROPER COMPARISON. CONTRACTOR SHALL SUBMIT SAMPLES OF ANY PROPOSED SUBSTITUTION. ANY SUBSTITUTION USED WITHOUT APPROVAL SHALL BE SUBJECT TO REJECTION AND REPLACEMENT AT CONTRACTOR'S EXPENSE.

d. CONTRACTOR SHALL, AT ITS EXPENSE, MAKE ANY CHANGES REQUIRED IN DETAILS, DIMENSIONS, ARRANGEMENT, EQUIPMENT OR ANY OTHER ADDITIONS OR ALTERATIONS TO THE WORK RESULTING FROM ANY APPROVED SUBSTITUTION INITIATED BY THE CONTRACTOR. SUCH CHANGES MUST BE APPROVED BY THE OWNER'S REPRESENTATIVE. THE ENTIRE SYSTEM TO WHICH THE SUBSTITUTION APPLIES AND ALL WORK INSTALLED IN CONNECTION THEREWITH OR RELATED THERETO MUST FUNCTION AS A UNIT AS ORIGINALLY INTENDED.

PERMITS, FEES AND NOTICES

- a. CONTRACTOR SHALL SECURE AND PAY FOR ALL PERMITS REQUIRED TO PERFORM THE WORK AND SHALL FURNISH OWNER WITH COPIES. CONTRACTOR SHALL ALSO SECURE AND PAY FOR ALL OTHER NECESSARY, LICENSES, WARRANTS AND ANY OTHER CONSENT OR APPROVAL OR AUTHORIZATION FROM ANY AGENCY, PUBLIC OR PRIVATE, REQUIRED FOR THE WORK OR ANY PORTION OF THE WORK. CONTRACTOR SHALL GIVE ALL NECESSARY NOTICES, PAY ALL FEES REQUIRED BY LAW AND SHALL OBSERVE AND ABIDE BY ALL APPLICABLE LOCAL, STATE AND FEDERAL LAWS, ORDINANCES, RULES, REGULATIONS AND CODES RELATING TO THE WORK AND TO THE PRESERVATION OF PUBLIC HEALTH AND SAFETY. BY ENTERING INTO THIS AGREEMENT, THE CONTRACTOR WARRANTS AND REPRESENTS THAT HE IS THOROUGHLY FAMILIAR WITH ALL APPLICABLE BUILDING CODES, ORDINANCES, LAWS OR OTHER REGULATIONS GOVERNING THE WORK.
- b. IF CONTRACTOR AT ANY TIME ASCERTAINS THAT ANY REQUIREMENT OF THE CONTRACT DOCUMENTS IS AT VARIANCE WITH APPLICABLE LAWS, ORDINANCES, REGULATIONS, OR BUILDING CODE REQUIREMENTS, HE SHALL IMMEDIATELY NOTIFY OWNER'S REPRESENTATIVE AND FURNISH WRITTEN NOTICE THEREOF. ANY NECESSARY CHANGES SHALL BE ACCOMPLISHED BY CHANGE ORDER. SHOULD CONTRACTOR FAIL TO GIVE NOTICE OF SUCH KNOWN VARIANCE AND PROCEED WITH WORK, HE SHALL BEAR ANY COSTS OR EXPENSES INCURRED IN MAKING CHANGES REQUIRED AS A RESULT OF SUCH VARIANCE.

MEETINGS

- a. THE CONTRACTOR SHALL MEET WITH THE OWNER'S REPRESENTATIVE AND BUILDING MANAGER IN ADVANCE OF CONSTRUCTION COMMENCEMENT TO:
- 1) SCHEDULE, SEQUENCE AND COORDINATE THE WORK
- 2) MAINTAIN AT ALL TIMES THE EXITS AND EGRESS WIDTHS REQUIRED BY CODES DURING ALL PHASES OF CONSTRUCTION WITHIN THE PROJECT AREA AND IN ALL PUBLIC CORRIDORS, STAIRS AND EXITWAYS.
- b. KEEP DISRUPTION OF THE FACILITIES' FUNCTIONS TO A MINIMUM DURING CONSTRUCTION.
